



# SCHOLARSHIP APPLICATION FORM

## 20<sup>TH</sup> ANNUAL SAN ANTONIO PARALEGAL DAY CELEBRATION

For the upcoming 2023 San Antonio Paralegal Day Celebration, the State Bar of Texas Paralegal Division - District 5 and San Antonio Paralegal Association will award (2) educational scholarships up to \$500 per recipient. The purpose of the scholarship is to make the pursuit of taking a paralegal certification exam (NALA, TBLS), or attending a CLE seminar (NALA, TAPS), a little more affordable and attainable to members of District 5 and SAPA.

#### In order to apply for a scholarship, you must meet the following requirements:

- 1. Current member (or apply for membership) of the State Bar of Texas Paralegal Division or San Antonio Paralegal Association.
- 2. Provide a written essay on the following topic:

#### "What does being a paralegal mean to you?"

The essay must be two (2) pages in length and double-spaced, Times New Roman 12 font.

- 3. Provide a letter of reference, which describes your involvement in the paralegal profession.
- 4. Financial need shall be a contributing factor, but not a requirement. However, if two or more applicants are equal in meeting the criteria for the scholarship, financial need shall be the determining factor.

### **Scholarship guidelines:**

- 5. No money will be sent directly to the recipient.
- 6. Scholarship shall cover the cost of up to \$500 per recipient and is to be used in the 2024 calendar year.
- 7. Scholarship recipient(s) will be announced at the San Antonio Paralegal Day Celebration on October 20, 2023.
- 8. Recipient is required to volunteer a minimum of three (3) hours at a PD or SAPA event in the 2024 calendar year.
- 9. The scholarship selection committee shall be composed of the 2023 Paralegal Day Planning Committee.
