I was first introduced to criminal defense working in Corpus Christi as a legal assistant to Doug Tinker in 2004, and I've continued working uninterrupted in this field ever since.


the family that I am working for and how I can best serve. It doesn't always end in a transaction, but there is often a good ending and growth for me.
