

We spring forward on Sunday March 10th

Have you ever wondered what Daylight Saving Time (DST) is?

Daylight saving time (DST) claims a variety of other names: daylight *savings* time, daylight time, summer time (not to be confused with *summertime*). It refers to the practice of setting clocks forward by one hour during the warmer months of the year, and then setting them back one hour in the fall.

One way to remember the pattern: "spring forward, fall back."

The idea dates back to World War I, although some credit Benjamin Franklin for daylight saving time due to a satirical letter, he wrote in 1784 stating: "Every morning, as soon as the sun rises, let all the bells in every church be set ringing:

and if that is not sufficient, let cannon be fired in every street to wake the sluggards effectually."

To maximize resources for the war, Germany and Austria implemented the first daylight saving time in 1916. The U.S. did the same in 1918.

The general idea of daylight saving time is to maximize the use of natural daylight. This always occurs around the summer months. As the earth moves around the sun and is tilted on its axis, certain parts of the world experience longer days during certain months. For those in the northern hemisphere, like the U.S., these longer days run from March to November, with June to August seeing the longest days.

For those in the southern hemisphere, the seasons are reversed: June through August mark winter months and are therefore the shortest of the year.


I am Priscilla Nash the Public Relations Director for SAPA and Pro-Bono Sub Chair for District 5

Traditional Irish Soda Bread

Ingredients:

- 4 cups all-purpose flour
- 1 teaspoon baking soda
- 1 teaspoon salt
- 1 and 3/4 cups buttermilk

Instructions:

- 1. Preheat your oven to 425°F (220°C). Lightly grease a baking sheet or line it with parchment paper.
- 2. In a large mixing bowl, sift together the flour, baking soda, and salt.

- 3. Make a well in the center of the dry ingredients and pour in most of the buttermilk. Mix with a wooden spoon until you have a soft, slightly sticky dough. Add more buttermilk if necessary.
- 4. Turn the dough out onto a floured surface and gently knead it for a minute or two, just until it comes together.
- 5. Shape the dough into a round loaf and place it on the prepared baking sheet.
- 6. Use a sharp knife to score a deep cross into the top of the loaf.
- 7. Bake in the preheated oven for 15 minutes, then reduce the heat to 400°F (200°C) and continue baking for another 25-30 minutes, or until the bread is golden brown and sounds hollow when tapped on the bottom.
- 8. Remove the bread from the oven and transfer it to a wire rack to cool completely before slicing and serving.
