**Dinosaur-Themed Corn Maze** - A 10-acre corn maze at San Antonio's Traders Village will be open weekends from Oct. 7 through November. Hours are 10 a.m. to 5 p.m. Saturdays and Sundays.

Spooky Spider Cookies

#### Ingredients:

1 batch of your favorite chocolate cookie dough (homemade or store-bought)

Pretzel sticks (for spider legs)

Chocolate chips (for spider bodies)

Candy eyes

Optional: black icing for decorating

Instructions:

Preheat your oven according to the cookie dough recipe.

Roll the cookie dough into small balls and place them on a baking sheet lined with parchment paper.

Press 4 pretzel sticks into each cookie ball to create the spider legs.

Bake the cookies following your dough recipe's instructions, usually around 10-12 minutes. Make sure the pretzel legs don't burn.

As soon as you remove the cookies from the oven, press chocolate chips into the center of each cookie for the spider bodies.

While the chocolate is still soft, attach candy eyes on top of the chocolate chips.

Let the cookies cool completely.

If desired, use black icing to draw spiderweb patterns on the cookies for added spookiness.
